

This subject was identified during this investigation as a **1004** teacher from the Sandy Hook Elementary School.

Location:

The interview took place in an office area at the Trumbull Police Department, 158 Edison Road, Trumbull, Connecticut. Present during the interview were detective Richard Covello #376 and I. The interview began on December 14, 2012 at approximately 1840 hours and ended on December 14, 2012 at approximately 1910 hours.

Action Taken:

That on December 14, 2012 at approximately 1840 hours, Detective Richard Covello and I spoke with and obtained a written statement from

was identified during this investigation as being an employee of Sandy Hook Elementary School.

04 related that she is 04 04 teacher at Sandy Hook Elementary School and she has been employed there for approximately 04 years.

04 stated that on December 14, 2012 at approximately 8:30 A.M., she got her classroom ready and greeted her students as they arrived. After her students arrived, she took attendance, lunch count and had a morning meeting.

At approximately 9:30 A.M., 04 related that she heard a loud noise and immediately instructed her students to move into a corner of the classroom, crouch to the ground and stay silent. 04 stated that as she proceeded to her classroom door to lock it, she heard the custodian run down the hallway and state, "I think there's a shooter in the building." 04 stated she locked the door and as she proceeded back towards her students, 04 stated to knock on the door. Martin stated that she unlocked the door and quickly let 04 in. 04 stated that as they waited and listened, she heard multiple gun shots and a "female voice" state, over the school's loudspeaker, "The kids. the kids."

o4 stated that at approximately 9:40 A.M., she called 911 and was informed by the dispatcher that the police were on their way. 04 stated that she held her students hands and reminded them to stay crouched down and silent. 04 continued to state that she could still hear more gun shots after she called 911.


further related that at some point, she observed a Newtown Police Officer exit a door from the library and start to look around the courtyard. Shortly after, **04** stated someone banged on her classroom door and stated, "Police, we're evacuating." **04** stated that she instructed her students to hold hands and then they proceeded out the classroom door and down the hallway where they exited out the rear, side door. Once they exited the school, they walked to the Sandy Hook Fire Department.

Lastly, 04 related that she never witnessed the shooter, however she did hear someone run down the hallway and scream, "Don't fucking move."
