**INTERVIEW REPORT:**

04, 03

On 12/14/12, I responded to the Sandy Hook Elementary School in Newtown, CT. Upon arrival, I met with Sgt. Brent Aitken and assisted the students and teachers entering the firehouse from the school. Teachers lined up according to grade, and were asked to take a count of their students prior to releasing them to a parent. I later met with teacher 04, who was extremely distraught and crying. She gave me a handwritten list of the children in her classroom and the parent they were released to. (Refer to attached). She, in the company of her husband, provided the following detailed, statement in her own handwriting:

"I am one of 04 teachers that were meeting in the family resource room for a team meeting. At approx 9:30 am loud bangs were heard coming from the front office/door area. It sounded like tin shelving hitting the floor. At first we ignored it thinking someone dropped something off of

a cart going down the hall. I got up to go see and 04 followed me. I opened a door and saw Rick Thorn our custodian- he told me to get back inside and hide. At that point we all thought it had to be gunfire. Too numerous to count, bullets- so many bullets. Everyone tried to find a place to hide. We turned the lights out. I told him to call 911. Not sure who- 04 opened a small window going to back of school- They all went out the window and ran up into the woods (I think)- 04 ran out the door and I yelled for him to stay and hide. I stayed in the room and hid in the corner. Christmas presents were all in bags waiting to be wrapped. I took the bags and covered myself with them and waited. While we were in our meeting- right after shots were fired- I heard the intercom come on- people crying and screaming- someone was saying something but I couldn't make it out. It was like someone picked up the phone and put it down on the desk so people could hear and maybe call for help?? Before 04 left- the bullet sounds got louder as if the (gunman?) was coming down the hall. Lots of bullets- then the sounds got weaker- maybe he went back down the office way. Everyone gone now- I am alone- I tried to cover myself with the shopping bags. I heard the door open and I stayed very quiet. I couldn't see who it was- police? gunman? nobody said who it was- so I stayed quiet. Time went by, I'm not sure how long. I don't hear any more bullets now. I peaked around the wall and saw police outside the window with guns. I knocked on the window and the officer turned quickly- I scared him (sorry) but I put my hands up, opened the door and said I was a teacher. He told me to go back inside and hide. More time passed- not sure how long. I snuck up to the table to get my phone. I called my husband and stayed on the telephone with him until I could get out. I saw police running outside- where 04 went- Soon after, a police officer knocked on the door and announced he was an officer. He took me out of the building. I saw 2 dead people by the office door. I ran with the officer and waited outside to get my kids. My kids were with 04 teacher. I was directed to the fire house where I found all 19 of my students. We waited together until all my kids were released with a parent or known parent from my classroom." (Refer to attached written statement).
