04 was attending a meeting within conference room #9 during the Sandy Hook School shooting.

ACTION
TAKEN:

On 02/15/13 at approximately 0914 hours, Detective Peters and I met with 04 within Chalk Hill School. 04 stated verbally and later in a sworn written statement that as soon as the PPT meeting started she heard what sounded like metal chairs falling. It was a "boom, boom, boom", approximately five to ten consecutive sounds. Dawn, Mary and Natalie then ran out of the room, but before Dawn had ran out she stated to us, "stay here" as if she knew something was wrong. The remainder of us in the room got down to hide. Shortly after, Natalie came back into the room and she stated that she had been shot twice. Natalie laid down in front of the door with her head towards the printer. Natalie was also holding the door handle, preventing anyone from coming inside. During this time, 04 had heard anywhere from 100 to 200 gun shots. 04 didn't hear any talking but recognized the sounds of children screaming and crying. The shooting would continue, stop and then pick up again. 04 did hear someone walking and it felt like the steps were getting closer and then further away. As the shooting continued, 04 did hear the sounds of doors being shut, which she knew were the teachers closing their doors. 04 then heard one more gunshot which sounded completely different than the others. This last shot sounded like it came from the lobby area. The school then became quiet. 04 stated that the initial gun shots sounded like they came from the lobby with the other shots coming from the right side of her door. 04 then recognized the sound of Police radio, which is when she knew it was going to be ok. 04 remembers one Officer yelling at a little girl to get back into the room. The only child voice 04 heard was this little girl who stated that she is all alone (See attached written statement for details.)
