04 was attending a PPT meeting within conference room #9 during the school shooting.

ACTION
TAKEN:

On 02/15/13 at approximately 1014 hours, Detective Peters and I met with 04 within Chalk Hill School. 04 stated verbally and later in a sworn written statement that on 12/14/12 she entered conference room #9 at approximately 9:32 am. She then heard a metallic sound which sounded like metal chairs falling down. The noise did not register in her mind as being gun shots. The noise sounded like it was coming from the lobby area. Dawn, Mary and Natalie got up and left the room. Dawn then shouted back from the hallway, "shooter, stay put". Someone had then shut the conference room door and everyone hid. 04 heard what seemed like 100's of gun shots. The gun shots were getting closer to the conference room and then it sounded as if the gun shots went passed the room. 04 does not remember the gun shots coming back towards them. During the shooting, there were quick pauses and then the shooting resumed. A short time later, Natalie came back into the room and stated that Dawn and Mary were shot and she thinks they are dead. Natalie also stated that she was shot. Natalie stated that the shooter had a small build and was wearing a mask, but couldn't tell if it was a man or woman. 04 never heard footsteps but did hear the shouts and screams of children. 04 did not hear doors opening or closing. She does remember hearing Police sirens.

Later in the day, Natalie told 04 that Mary and Dawn were directly in front her, shielding her from the gun shots which is the reason why her injuries were on her left side.

At a later date and time, 04 visited with Natalie at her residence. Natalie stated that when Dawn, Mary and she were shot, they all went down together and Natalie played dead. The shooter then went into the office and at that time she was able to crawl back into conference room #9 (See attached written statement for details.)
