CTION TAKEN: On 02/13/13 at approximately 1420 hours, Detective Mudry #824 and I met with 04 at SHES, with gards to the ongoing investigation. The purpose of this interview was to ask clarifying questions of statements that she had given in her previous
terviews. During the interview, 04 of stated, in part, the following:
hat on 12/14/12, she was
stated that when she saw him, he was immediately shooting. 04 stated that she ducked under 04 desk (a woman in the office
the hadn't arrived to work yet). 04 stated that she heard the office door open and she heard the male walk in. The male walked in a normal ray or pace, did not say or mumble anything and was breathing normal (no heavy or excited breathing). The male walked into 04 office (the curse) and then walked out. 04 stated that she heard more gunshots, but does not remember hearing any screaming or talking, just the cunshots. 04 stated that when the shooter came in, he was holding the gun up high near his shoulder and it was pointed down the hallway. Thortly after the shots fired in the lobby, he came into the office. 04 also stated that the shooter did not ask to be buzzed in because she would have been the person to buzz anyone in.
