ACTION TAKEN: On 02/13/13 at approximately 1420 hours, Detective Mudry #824 and I met with [REDACTED] 04 at SHES, with regards to the ongoing investigation. The purpose of this interview was to ask clarifying questions of statements that she had given in her previous interviews. During the interview, [REDACTED] 04 stated, in part, the following:

That on 12/14/12, she was [REDACTED] 04 in the office when she heard a pop and glass breaking. [REDACTED] 04 stated that she immediately stood up and saw a white male standing in the lobby. [REDACTED] 04 stated that he was standing at the second pane of the office window from the door. There are four panes to the window. [REDACTED] 04 stated that she saw a side profile of the male and he was facing down the hallway toward the first grade rooms. [REDACTED] 04 stated that when she saw him, he was immediately shooting. [REDACTED] 04 stated that she ducked under [REDACTED] 04 desk (a woman in the office who hadn't arrived to work yet). [REDACTED] 04 stated that she heard the office door open and she heard the male walk in. The male walked in a normal way or pace, did not say or mumble anything and was breathing normal (no heavy or excited breathing). The male walked into [REDACTED] 04 office (the nurse) and then walked out. [REDACTED] 04 stated that she heard more gunshots, but does not remember hearing any screaming or talking, just the gunshots. [REDACTED] 04 stated that when the shooter came in, he was holding the gun up high near his shoulder and it was pointed down the hallway. Shortly after the shots fired in the lobby, he came into the office. [REDACTED] 04 also stated that the shooter did not ask to be buzzed in because she would have been the person to buzz anyone in.
