04 was attending a PPT meeting within conference room 9 during the Sandy Hook School shooting.

# ACTION TAKEN:

On 02/19/13 at approximately 0917 hours, Detective Peters and I met with 04 within the Connecticut State Police Southbury barracks for a subsequent interview. 04 stated the following in a sworn written statement: "I am the 04 at Sandy Hook School. On 04 had started speaking 12/14/12 at 9:30 am, I was attending a PPT meeting in conference room 9. By 9:35 am we had already started. and then shortly after I heard a noise coming from the lobby. I initially felt that the noise was gun fire. The noise was loud with the sound of glass crashing. All of us in the room, stood up. This initial round of gun fire continued rapidly with crashing. Dawn, Mary and Natalie, in this order left the room, all together in single file. Shortly after, a second round of gun fire ensued, which is when I believe Dawn and Mary were killed. When Dawn, Mary and Natalie had left the room, the conference room door was shut but I can't remember how it was closed. The rest of us in the conference room hid. I hid under a table to the left of the door, as you walk in. When Natalie returned to the room, I remember the shooting kept continuing. Natalie had told us that she had been shot. Natalie was holding the door shut with her right arm. I reached out to Natalie, holding her foot. The shooting continued with rapid fire, then a pause, rapid fire and pause, etc. I heard the shooting coming towards us then away from us. Then the shooting came closer to us again. I could not tell the difference in the gunfire, to me it all sounded like rapid fire and it just kept going. I heard children screaming throughout the incident. I felt that the event lasted at least 10 minutes. At this point, Natalie stated that she can't hold the door anymore. Dawn and I then pulled Natalie away from the door, laying her flat and I inspected her wounds. As this was going on, a parent in the room was on the phone with 911. When we were calming Natalie, is when we heard voices, which we assumed were first responders. Our door then opened, it was a Paramedic and a Police Officer. The Officer then told us to wait and they closed our door. We waited in the room for another 5 to 10 minutes." (See attached written statement.)
