ACTION TAKEN: On 02/15/13 at approximately 1212 hours, Detective Mudry # 824 and I met with [04], a teacher at SHES, with regards to the ongoing investigation. The purpose fo the interview was to clarify stements she made in her intial interview. During the interview, [04] stated, in part, the following:

That on 12/14/12, she was covering for [04] with one student, [01 02 03 12]. [04] stated that she was just about to step into the hallway to go to her original classroom [04] when she heard consecutive "popping" noises. [04] stated that it originally sounded as if someone was folding metal tables, so she knew it was near the lobby of the building where the cafeteria was. [04] stated that [04] came to the door of room 6 at the same time and they looked at each other with a look of "what the hell is that?" and actually said it. [04] stated that she and [04] then closed their classroom doors. [04] stated that she did not put paper on the window or lock the door. [04] stated that she took her student into the bathroom. [04] stated that the "popping" noises sounded as if they were coming very close to her. [04] stated that there was a pause and then it started moving away from them. [04] stated that she heard children screaming. [04] stated that she heard an adult male yelling and it was more muffled and the shooting hadn't stopped yet. [04] stated that she also heard someone yelling something to the effect of what she thought was, "get down", and assumed it was the Police in a confrontation with the shooter. [04] also stated that when she did leave classroom 3, she saw drops of blood outside her door and it looked like someone was walking and dripping blood.
