with regards to the ongoing investigation. The purpose of this interview was to ask clarifying questions of a statement that she had given in her previous interview. During the interview, [04] stated, in part, the following:

That on 12/14/12, she was teaching in [04] At approximately 9:30 - 9:35 she heard something that sounded like fireworks coming from the main lobby. [04] stated that she immediately closed her door and gathered her kids to the corner of the room facing the courtyard. [04] stated that when she closed her door, she looked across the hall at Lauren Rousseau, who was closing her door at the same time. [04] stated that she knows Lauren well. [04] stated that they did not speak but they both had a look of horror on their faces. [04] stated that she did not put paper over her window. [04] stated that the shots sounded like 1,2,3 then small pauses and then there was a long pause but it started up again. [04] stated that she could not tell where the shots were going or if she heard kids screaming for some reason. She just remembered a lot of noise. [04] stated that when she heard a long pause, she went to her door and locked it and then put the paper over the window. She could smell the gun powder. [04] stated that she went back to reading to the children. [04] stated that her students told her that someone was jiggling the door knob and that it was the police.
