

ACTION TAKEN: On 02/19/13, at approximately 1505 hours, Detective Mudry #824 and I met with **Control of Control of Contro**

That she is a teacher in 04 and was doing yoga with the students when she heard a large crash like metal hitting the floor. 04 stated that she did not think anything of it and continued. Then she heard a "bang" which seemed 3 or 4 at a time. Then she heard a pause and then the "bangs" continued in a consistent manner. 04 stated that she ordered the children to the backpack area. She grabbed her keys and attempted to lock her door but when she went to go "scoot" outside the class, she felt as though a "threat" was close to her. 04 stated that she slammed her door shut, which was the only way that she could close it. 04 stated that the "bangs" appeared as though they got closer to her, then went by her again towards the lobby. 04 described the bangs as really loud and non-stop. 04 stated that she heard children screaming and she heard the loud speaker. 04 stated that she was unsure if she saw Soto close her classroom door. 04 stated that she heard the police sirens and eventually the "bangs" stopped.

During the interview, 04 stated that the metal sound was more like the metal door frame in the lobby falling on the floor or the roof of the building falling in. 04 stated that she is unfamiliar with gunfire and said to herself that the noise couldn't have possibly been gunfire. 04 also stated that she heard the intercom, and children screaming, but she did not hear other voices or the shooter speak.

CASE STATUS: This case will remain open pending further investigation.
