On 12-14-2012 at approximately 1310 hours I, Trooper Slaiby #1132, interviewed teacher [Redacted] 04, 03 who provided me with a sworn written statement and the following is a summary of that statement. [Redacted] 04 stated that she is a [Redacted] 04 teacher at Sandy Hook Elementary School. [Redacted] 04 stated that she arrived at work at about 0805 hours that morning and parked in the parking lot in front of the main doors. [Redacted] 04, 01 02 03 12 walked into the main doors and did not see anything suspicious in the parking lot.

04 stated that she signed in at the main office and saw Hochsprung there talking to several teachers (04 and Mary Sherlach). 04 stated that 04, 01 02 03 12 for a book club meeting. 04 stated that she went to the cafe to order two slices of pizza for lunch. 04 stated that she went back to the main office to get 04 and to get her bags. 04 stated that she was 04

04 stated that she talked to Hochsprung for about 5 minutes in the office and then went to 04 and that 04 was there. 04 stated that students began arriving at about 0850 hours and that she was reading to some of them. 04 stated that she and 04 performed their daily classroom routines until about 0940 hours when 04 went to step into the hallway for something. 04 stated that 04 yelled "ah" and that they heard loud consecutive popping noises in the hallway. 04 stated that 04 immediately said "someone is in the building" and that she knew right away that 04 meant a shooter (04 stated that 04 is normally a "cool cat" and there was something in her voice that made her sound serious).

04 stated that she immediately had the kids herd into a corner of the room and that she heard consecutive shots the whole time. 04 stated that she thought to herself "when is it going to be empty?" 04 stated that she heard a lot of commotion over the loud speaker such as crying and voices. 04 stated that she was humming to the kids so they would not hear the loud speaker. 04 stated that two police officers came through the back door of the classroom and checked the classroom. 04 stated that 04 told police that she was not ok (as she had been shot in her foot). 04 stated that she filed the kids out the back door after the police officer told her to leave with the kids. 04 stated that all of her students were accounted for once they were outside. 04 stated that kids asked 04 what was wrong with her foot (as it was bleeding) and that she told them she stepped in red paint. 04 stated that she filed her students into the fire house and awaited for police instruction on what to do. 04 stated that she did not see the shooter or hear if the shooter said anything. 04 stated that she believes that 04 saw the shooter when she had opened the door and was struck in her foot by gunfire (SEE ATTACHED STATEMENT).

I later was tasked by State Police supervisors to perform perimeter security with Trooper Bombace #421 on the wood line surrounding the school until approximately 1830 hours.
