That on 12/14/12, she was at SHES for a PPT meeting in room 9. Just as the meeting was to begin, the group heard a noise from the lobby and it sounded like a popping and crashing noise together and like chairs falling down. O4 stated that Dawn (Hochsprung) got up and went around the table toward the door with Mary (Sherlach) behind her. Natalie (Hammond) followed shortly behind. O4 stated that Dawn asked "what was that?" O4 stated that Dawn said something else when they got to the hallway but she did not hear what they said or who spoke. O4 stated that she does not know how long Natalie was in the hallway, but she heard more pops and realized it was a gun. O4 stated that she went under the table and the others went to the corners of the room. O4 stated that when Dawn, Mary, and Natalie went into the hallway, that was when she heard 3 pops. O4 stated that she heard a break in the noise. O4 stated that then she heard shooting and kids screaming. O4 stated that she couldn't tell where the shooting was coming from (which room) but the shooting seemed to be moving away. O4 stated that she also remembered that the kids were being so quiet and she did not know if the shooter killed them or if they were just being good. O4 stated that she did not hear any talking outside the room.
