**ACTION TAKEN:**

On 03/06/13 Detective Downs #502 and I went to Chalk Hill Elementary School to obtain consent forms from [04] for the treatment of her gunshot injury at Bridgeport Hospital on 12-14-12. Upon obtaining said signed consent forms, we asked [04] if she was employed as a teacher at Sandy Hook Elementary School during the years that Adam Lanza had attended that school. [04] informed us that she started working there in [04] (Adam Lanza was a student) but she has no recollection of him and as far as she knows, she did not have him as a student.

**CASE STATUS:** This case will remain active pending further investigation.
