ACTION TAKEN:

On 04/25/13, at approximately 0905 hours, Detective Mudry #824 and I met with **04, 03** at Chalk Hill Elementary School with regards to the ongoing investigation. The purpose of this interview was to obtain more information and clarify her original statement given on

12-14-12. During the interview, 04 stated , in part, the following:

On 12-14-12, she was participating in a PPT meeting in the conference room located near the office of the school. It was to start at 9:30 AM.

04 stated that in the meeting was Dawn Hochsprung, Mary Sherlach, Natalie Hammond, 04. The meeting started and 04 was going to speak first. 04 stated that she heard a succession of 3 gunshots and she knew them to be gunshots (in her opinion). 04 stated that Dawn (Hochsprung), Mary, and Natalie jumped up and Dawn said very expressively "Oh my god, that sounded like gunshots." The three women exited the room with Dawn, first, Mary, second, and Natalie, third. Mary and Dawn went out almost as one, practically on top of each other. Natalie was about a step or two behind. After the three went out into the hallway, 04 stated that she heard a number of shots. 04 stated that she did not know the exact amount but at this point knew for sure the noise was gunshots. 04 stated that prior to the second round of gunshots (in which the three women were shot), 04 grabbed the phone to call the office, she dialed but no one picked up. 04 stated that at the second round of gunshots, they all scrambled under the tables into hiding spots and 04 tried to hang up the phone, but could not and the phone was hanging there. 04 stated that 04 also grabbed 04 pocketbook to give her the cell phone. 04 stated that she was already on the phone with 911 when Natalie came back into the room. 04 stated that the 911 operator was asking her "did you see him?" "can you describe him?" 04 also stated that the 911 operator also asked her about Natalie's injury and told her what to do for Natalie. 04 stated that she could not move because she was frozen in fear, so she told 04 what to do for Natalie. At this time, 04 stated that Natalie was holding the door shut. 04 stated that the sound of the gunshots originated in the lobby area. The second round sounded like Dawn, Mary, and Natalie got shot as soon as they went out the door, and then there was a pause. 04 stated that when the gunshots started again, after the pause, the gunshots sounded as if they were moving away from the conference room. 04 stated that the shots did not sound like they were moving back toward the conference room. 04 stated that the shots sounded like they were coming and coming, well over a hundred in number. 04 stated that the gunfire all sounded the same to her. 04 stated that she never heard the children screaming nor did she hear the shooter move or speak. 04 stated that she hung up the phone when the first responders arrived to their room.
