



04 04 also verbally stated, when asked, that she did not see the other children, who at that time should have been in Mr. Rosen's driveway. also stated that she is not sure if she would have noticed them as she was focused on getting to the police department.

See attached written statement prepared and notarized by this Detective, witnessed by Detective Downs, and sworn to and signed by 04

Detective Downs and I measured, with his department assigned vehicle's odometer, the distance from the intersection of Riverside Drive and Cherry Street to Dickinson Drive, and the distance is approximately a 1/4 mile. We estimated that the children ran approximately a 1/2 mile from the entrance of the school.

CASE STATUS: This case will remain active pending further investigation.
