04 at her residence; 04, 03 . 04 was an employee of the Sandy Hook Elementary School in the Town of Newtown. She provided the following verbal and sworn written statement regarding what she saw the morning of the shooting at the Sandy Hook Elementary School:

04 explained that on Friday December 14, 2012 at approximately 1015 hours, she arrived at the Sandy Hook Elementary School to report for work. As she pulled up to the school, she observed Police Officers already on scene exiting their vehicles with their firearms drawn. 04 stated that she never entered the school. 04 was then redirected by on scene Emergency Personnel to go directly to the Newtown Fire Department located up the road from the school and assist with caring for the students that had been gathering there. 04 concluded by stating that she had been employed at the school for the past 04 years and did not recognize the last name "LANZA" as a current or former employee there.
