WITNESS INTERVIEW REPORT: **04**

On May 8th, 2013, from approximately 1305 hours to 1335 hours, Det. R. Van Ness and I met with witness, **04**, at her residence. **04** invited us into her home where we conducted the interview in the living room, obtaining a written statement. **04** stated verbally and later in a sworn written statement that on December 14th, 2012 she dropped off her children and headed to Sandy Hook for an event at 9:45 am. She was driving by herself on Riverside Rd. in Sandy Hook heading towards the school in a westerly direction. She had not yet seen the firehouse on the corner, when she observed five (5) first graders running towards her, waving their arms in the air. The children were running on the side of the road the fire house is on. **04** knew that the children were first graders because she recognized four (4) of the students **01 02 03 12**. She initially drove by the first graders, and then turned around. When she arrived, **04** was stopped with the kids and there was an unknown male also stopped (male appeared be in construction work based on clothing). The kids stated that there is a man at the school with a gun, killing everyone and **01 02 03 12** kept saying that **01 02 03 12** is dead. **04** then got into **04** mini-van with the children. **04** called the school and received no answer so she called the Police Department and was instructed to drive the children to the Police Department. **04** then got into her vehicle and followed behind **04** to the Police Department. Upon arrival, the children were very frantic and they were instructed to sit in the interview room. At this point, **01 02 03 12** said something to the effect of, her teacher is dead. **04** told **01 02 03 12** that it's not true and **01 02 03 12** replied that there is a lot of blood. **04** learned that the fifth child's name is **01 02 03 12** **01 02 03 12** mother then showed up at the Police Department, so **04** left and drove to the firehouse with her friend to **01 02 03 12**.

From what **04** remembers, the children did not mention any descriptors of the shooter or of any other children that were injured (See attached


