Location:

The interview took place in my assigned vehicle, which was parked in the area of 12 Dickinson Drive, Sandy Hook, Connecticut. The interview began on December 14, 2012 at approximately 1155 hours and ended on December 14, 2012 at approximately 1240 hours.

Action Taken:

That on December 14, 2012 at approximately 1155 hours, I spoke with and obtained a written statement from [redacted] 04 was identified during this investigation as [redacted] 04 for Sandy Hook Elementary School.

[redacted] 04 stated that she is a [redacted] 04 resident and has been an employee of the Sandy Hook School system for the past [redacted] 04 years. Moreover, [redacted] 04 stated that for the past [redacted] 04 years, she was hired as [redacted] 04.

[redacted] 04 stated today, December 14, 2012, at approximately 0930 hours, she was in room 9 for a PPT meeting with Dawn Hochsprung, Natalie Hammond, [redacted] 04 [redacted] Mary Sherlach. [redacted] 04 stated that the meeting was just about to begin when she heard a very loud metallic sound from the hallway. At that moment, Hochsprung, Hammond and Sherlach ran out of the room and into the hallway. [redacted] 04 stated that the remaining people in the room started to follow, but an unknown person shouted, "get back, stay put." [redacted] 04 stated that the remaining people stayed in the room and hid under tables. [redacted] 04 also stated that as everyone was hiding, she heard what she believed was continuous gunshots.

After a period of time, [redacted] 04 stated that Hammond returned back to the room, and it was at that time she noticed Hammond was shot twice, once in the leg and once in what appeared to be the arm or hand. [redacted] 04 stated that when Hammond re-entered the room, she immediately laid on the floor and held the door closed. [redacted] 04 stated that as Hammond was holding the door closed, she stated that Sherlach and Hochsprung were also shot. According to [redacted] 04 [redacted] 04 subsequently retrieved her cellular telephone and called 911. [redacted] 04 stated that while [redacted] 04 was talking with 911 dispatchers, she could still hear gunshots. [redacted] 04 continued to relate that she never observed the gunman, but Hammond did tell her that the shooter was wearing a mask.

[redacted] 04 stated that after approximately fifteen minutes, police officers arrived and entered their room. [redacted] 04 stated that the officers immediately started to administer first aid to Hammond. [redacted] 04 stated that shortly after the officers arrived, they instructed them to start evacuating the children from the school.

Lastly, [redacted] 04 stated that during the evacuation, she observed two bodies in the hallway. She recognized one of the bodies as Dawn Hochsprung. [redacted] 04 stated that after walking past the two bodies, she began to escort children from the school to the Sandy Hook Fire Station.
