

That on December 14, 2012 at approximately 1251 hours, I spoke with and obtained a written statement from Richard Thorne Jr. Thorne was identified during this investigation as a Custodian for Sandy Hook Elementary School.

Richard Thorne stated that he is the evening shift Custodian for the Sandy Hook Elementary School and has been an employee of said school system for eight and a half years. Thorne stated today, December 14, 2012, he arrived at the Elementary School at approximately 0620 hours. Thorne stated that the reason he was at the school during the day was because he was replacing the Head Custodian. Thorne stated that upon his arrival, he opened doors and took an oil reading. During this time, he did not observe anything unusual.

Thorne stated that he did not know the time, but he was standing in the hallway by the custodian office when he heard a "shot" type sound and glass breaking. Thorne stated that he immediately took his cellular telephone out of his pocket and ran towards the lobby and then down the hallway, towards the gymnasium. Thorne stated that the reason why he proceeded towards the gym was to contact 911. Thorne stated that while he was speaking to a 911 dispatcher, he was instructing the teachers to stay in their classrooms and lock the doors. Thorne continued to relate that he could hear gunshots the entire time that he was speaking with the dispatcher. Thorne stated that the gunshots continued until the police arrived.

Thorne stated that he first observed police officers approaching from the school lobby. Thorne stated that as the officers approached, they instructed him to lay on the ground. Thorne stated that he complied and as he laid on the ground, the officers handcuffed him and escorted him out of the building.

Lastly, Thorne related that as he was being escorted out of the school, he observed two adult females lying in the hallway by the office. Thorne stated that they were near a bench and they both appeared shot. Moreover, Thorne stated that he did not recognize them, but he did notice that one of the females was wearing an orange dress.
