During the interview, 404 attempted to locate her telephone records for 12/14/12 to determine what time it was that she called her husband, and was unable to find the records, but knew she saved them somewhere. 404 later called me and left a message that she found the records and her telephone records indicated that it was 9:40 AM when she arrived at the school and called her husband.

Upon further review of Newtown Police Officer SGT Bahamonde's dash cam video, I was able to find parked at the stop sign at the end of Dickinson Drive prior to the driveway to the school in her Nissan Pathfinder. The video also shows the cars pulled over on Riverside Drive, The time stamp on the video was 09:40:04.
