DATE AND TIME OF INTERVIEW:

Wednesday, January 16th, beginning at approx. 1935 hrs. and ending at approx. 2130 hrs.

LOCATION OF INTERVIEW:

04, 03

04 was the 04 at the Sandy Hook Elementary School, in which twenty children and six staff members were killed on 12/14/12. 04 04 was absent that day due to a medical appointment. She had been interviewed by detectives on two earlier occasions but additional information was needed from 04 and detectives wanted to provide some information to her for her own well-being.

INTERVIEWEE:

ACTION TAKEN:

On the above-mentioned date and time, Det. Rachael Van Ness and I met with **04**, for this pre-arranged interview. We all sat at their kitchen table. At the onset of the interview we provided them with an Office of Victim Services Benefits Letter (dtd 01/15/2013) and a CT Department of Mental Health Packet. We then briefed them on the timeline of events (as of 01/15/2013) and described the basic movements and actions of the shooter.

04 then explained that the last actual "lockdown" that she remembered was about four years earlier when there was a bank robbery in the area. She stated that there was a predesignated code phrase that would alert the staff to lock their doors. She then explained that the plan was to line the children up in the cubby hole area and have them sit under where their backpacks were kept. This would keep them from being seen from the door. She also said that the teachers were to read books to the children during this time.

04 was then showed some sterile sketch maps of her classroom and asked about some of the standard operating procedures and seating positions. She stated that the children would put their lunch boxes under their desks because they would have snacks at 11:00 - 11:15am. She further explained that the same would probably happen in Miss Soto's classroom (#10). She then clarified that some of the children might just put their snacks at their desks instead of their actual lunch boxes. **04** then described some of the seating arrangements but she also said that it was hard to remember because the desks had been moved after Thanksgiving. She then stated that **04** Rachel D'Avino and Lauren Rousseau, were new to the school.
