On August 12th, 2013, Officer Adam Greco dropped off a signed and sworn written statement to the State Police barracks in Southbury. According to the statement, it was completed on June 27th, 2013 from the hours of 0015 to 0120. Off. Greco stated in a sworn written statement that on December 14th, 2012 he had worked until 0330 hours on a DWI patrol. He was then scheduled to work a construction job with Off. Hull on Botsford Hill Rd. At about 1030 hours, Off. Greco began getting ready for his construction job when he received a phone call from Ansonia Off. Lovermi. Off. Lovermi stated that he had heard over the hotline that the State Police were dispatched to a school shooting. At this time, Off. Greco was unaware of any incident within his town. Off. Greco drove to the construction job with his portable radio on but heard nothing indicating a school shooting, so he assumed it was something minor. Arriving at the job, he couldn't locate Off. Hull so he texted him. Off. Hull replied in a text that he was at the school and many were dead. Off. Greco then responded to the Police station.

He arrived at the station at approximately 1052 hours where he found no Officers or command staff present with the exception of Off. Hayes Dispatch could only confirm that there had been a shooting and advised him that the interview room in the lobby was filled with children. At approximately 1056 hours, he entered the interview room and found five or six children aged 6 to 7. There were also some adults present. Off. Greco ascertained that these children had been in one of the classrooms where the shooting took place but had escaped.

01 02 03 12 At approximately 1058 hours, Off. Greco brought in along with her mother for an interview. of 102 03 12 explained that the bad guy shot her teacher and classmates. She further explained that the bad guy looked like an Army guy wearing what sounded like green fatigues.



She further stated that she only saw one bad guy. She further stated that she only saw one bad guy. She also stated that the bad guy didn't see them. They all ran out of the school, down the driveway and onto the road where they were picked up by a parent. Off. Greco contacted Sgt. Kullgren and provided him with the information that he obtained from In speaking with Sgt. Kullgren he didn't sound 100% sure that there was only one shooter.

At approximately 1152 hours a State Trooper brought in what was believed to be a suspect into the sally port.

Off. Greco continued the interviews with other children until approximately 1210 hours when State and Fairfield Officers arrived to take official statements. All of the children had a similar account of a single shooter and his clothing. The boys described the firearm as a bazooka.

At a later time, Newtown Sgt. Wisentaner and Off. Greco reviewed the Police station security footage and observed a woman in a white van bringing children in at approximately 0956 hours (See attached statement for details.)

This statement was notarized by Lt. Robinson of the Newtown Police Departmen.
