**ACTION TAKEN:**

On 12/14/2012 at approximately 1330 hours, I spoke with [REDACTED] 04, 03, about her accounts of the Sandy Hook Elementary shooting. In summary, 04 stated that on 12/14/2012 at approximately 0930 hours, she was in room 9 attending a P.P.T. meeting. She was in the room with the school principal Dawn Hochsprung, the school psychologist Mary Sherlach, teacher [REDACTED] 04 Lead Teacher Natalie Hammond, [REDACTED] 04 said approximately five minutes passed when they all heard gunfire. 04 said right at that moment, Hochsprung, Sherlach, and Hammond left the room to find out what was happening. Rapid gunfire continued and 04 said that about five minutes went by and Hammond returned back in the room with bullet wounds in her left leg and left hand. 04 explained the gunfire sounded as if it was moving down the hallway from room to room. 04 stated that a State Policeman and medic then arrived and they took Hammond out of the room but told the rest to remain inside. 04 stated upon leaving the room and building with children and police, she saw Dawn Hochsprung and Mary Sherlach on the ground and they had been shot. She said the two bodies were laying just prior to a bench in front of the main office, if moving in the direction of the exit. As she exited, 04 stated she noticed the panel window to the right was shot out (if looking from outside the building at the front door).
