**ACTION TAKEN:**

On 12/14/2012 at approximately 1300 hours, I spoke with [REDACTED] 04, 03 about her accounts of the Sandy Hook Elementary School shooting. In summary, [REDACTED] 04 stated that between 0940 and 0945 hours, she heard what sounded like gunshots outside her classroom. She said she looked outside her room into the hall and she saw Rick Thour {sic} running toward the front of the school. [REDACTED] 04 stated there were two kids in the hallway so she pulled them into her room (per the Sandy Hook Elementary School map, [REDACTED] 04 teaches in [REDACTED] 04 which is where she was for the duration of the incident), she got her keys, locked the door, and hid her students in a closet area. [REDACTED] 04 stated she heard many other shots fired and screaming and crying over the loudspeaker. [REDACTED] 04 said she read two books to the students and then began singing songs to attempt to drown out the sound of shots. [REDACTED] 04 then heard Police come to the door which is when she gathered the children and exited the building.
