On 12/14/2012 at approximately 1205 hours, I spoke with [REDACTED] 01 02 03 12 (with the permission of [REDACTED] 01 02 03 12, 04 [REDACTED]), about his accounts of the Sandy Hook Elementary School shooting. In summary [REDACTED] 01 02 03 12 stated that he was in [REDACTED] 01 02 03 12 with [REDACTED] 04. He said that two students were absent that day, [REDACTED] 01 02 03 12 said that his teacher had a meeting so his class went to the gym to meet [REDACTED] 04 class. He said he didn't know what time it was, but it was the same time they usually go to the gym on Fridays. [REDACTED] 01 02 03 12 said they entered the gym on the right side of the gym (the wall in front of them as they entered had pennants and flags or banners on it). After about five minutes, [REDACTED] 01 02 03 12 said he was facing the door he entered when he heard loud bangs coming from the door in front of him. [REDACTED] 01 02 03 12 said the bangs were very rapid, then would stop, and then continue rapidly again. He said his teachers then put signs up over the windows, which is when he heard footsteps pass the door he entered and continue toward the mobile classrooms. [REDACTED] 01 02 03 12 said he heard more gunshots, then walkie talkies and "put your hands up, don't shoot!" [REDACTED] 01 02 03 12 said the police then entered the door on the left side of the gym (facing the wall of banners). [REDACTED] 01 02 03 12 said the police then left the room and his teacher had everyone crawl into a closet. [REDACTED] 01 02 03 12 said the police then came back in and escorted him and his entire class to safety. [REDACTED] 01 02 03 12 stated that his entire class escaped safely.
