On 12-14-2012 at approximately 0940 hours I, Trooper Slaiby #1132, was off duty when I responded to the Sandy Hook Elementary School at 12 Dickinson Drive in Newtown after I heard Troop A broadcast that there was an active shooter inside the school. Upon arrival to the area, I followed a line of State Police cruisers into the scene and was directed to a staging area near a fire house. I arrived on scene approximately the same time as Trooper Bombace #421. I observed a chaotic scene of numerous young students and civilians running around as dozens of police officers, EMS, and fire fighters responded.

I deployed my shotgun from my cruiser trunk and immediately made contact with numerous Connecticut State Police supervisors on scene. State Police tactical team members were securing the school at that time so I secured my shotgun in my trunk and began to assist guiding the students into the fire house from the school. State Police supervisors directed Troopers to locate a teacher and to organize their class of students to determine how many students were accounted for at the fire house. I assisted [redacted] 04 teacher [redacted] 04 in organizing her students. [redacted] 04 stated that neither she nor any of her students had been injured by the shooter. [redacted] 04 stated that she had 18 students that day and that all students were accounted for. [redacted] 04 stated that she made contact with all parents of her students as she released them into their care.

After assisting [redacted] 04 I assisted numerous families and other law enforcement officers on the scene at the fire house. At approximately 1205 hours [redacted] 04 provided me with a sworn written statement regarding the school shooting and the following is a summary of that statement.

[redacted] 04 stated that she is a 04 grade teacher at Sandy Hook Elementary. [redacted] 04 stated that she arrived at school at 6:35 a.m. and parked in her usual parking spot near the front door. [redacted] 04 stated that she observed a red car near the front doors that she recognized to be custodian Rick Thorne's vehicle. [redacted] 04 stated that she entered the school through the front doors and signed in at the main office.

[redacted] 04 stated that she went to her classroom [redacted] 04 area of the building) after signing in at the main office. [redacted] 04 stated that she planned her classroom activities until about 8:25 a.m. [redacted] 04 stated that she then went to meet other teachers by the library and that they walked together to their weekly Friday meeting in room #20 (across from the staff lounge). [redacted] 04 stated that she was with teachers [redacted] 04 stated that principal Dawn Hochsprung came into the meeting about 10 minutes later and talked to them for about 20 minutes. [redacted] 04 stated that Hochsprung then left the meeting and that she and the teachers talked for about 20 more minutes before they suddenly heard loud bangs.

[redacted] 04 stated the bangs sounded like metal objects fell off of something and that they believed that the custodian may have dropped chairs. [redacted] 04 stated that [redacted] 04 looked into the hallway and that they heard another burst of loud bangs and that [redacted] 04 yelled for everyone to get down. [redacted] 04 stated that she and the other teachers hid around the room. [redacted] 04 stated that eventually she and several other teachers climbed out a window and ran away from the school to the Villa restaurant. [redacted] 04 stated that she was with [redacted] 04 and that [redacted] 04 later met up with them. [redacted] 04 stated that the teachers eventually met at a nearby Subway restaurant at Glen Rd. and Church Hill.

04 stated that a police detective from Redding drove them to the firehouse from Subway to account for their students. 04 stated that she found her students who had been with the gym teacher 04 during the shooting. 04 stated that she did not see who was shooting in the school. 04 stated that she heard static and crying on the school intercom during the shooting "as if someone was trying to make an announcement during the shots" (SEE ATTACHED STATEMENT).
