ACTION TAKEN:

On 12/14/2012 at approximately 1150 hours, I spoke with [REDACTED] 04, 03, about her accounts of the Sandy Hook Elementary shooting. In summary, [REDACTED] 04 stated that on 12/14/2012 at approximately 0930 hours, she was in what she believes was classroom 04. She was in the room with [REDACTED] 04, 01 02 03 12. [REDACTED] 04 stated that they began hearing a round of about 10 fast gun shots, and then a second round of the same thing. She stated that they shut the door to the classroom and all three of them got into the bathroom and locked the door. [REDACTED] 04 continued to state that she heard more rounds of gun shots and said they were getting closer to her room. She stated that about ten minutes into the initial sounds, the shots sounded like they were in the classroom next to hers, [REDACTED] 04 class at which time she could hear screaming and about three more rounds of shots. [REDACTED] 04 then stated that the door to her room was kicked open and she could hear things being pushed around for a minute or two. She stated that about ten minutes later they peeked out the door and saw police officers who helped them out of the building.
