

stated that it sounded like a woman's voice was trying to say something but she could not make it out. She then stated that she text a few people from her cell phone to tell them that there was a shooting at the school and to call the police. 04 stated that there was a period of about a minute when the shooting ended and then she heard 2-3 more individual shots and then she could hear the police officers in the building over the intercom. She stated that she and the class stayed huddled in the corner and that the police ended up coming into the room. 04 stated that she heard 04 say something about her foot and that after the police checked the bathroom and the closet they led her and the class out the rear door and down the sidewalk to the firehouse. 04 further stated that it wasn't until they were leaving the room that she saw that 04 had been shot in the foot.
