INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

On Friday, December 14th, 2012 between 1305 and 1325 hours I, Det. Roy # 518, interviewed [REDACTED] 04 is a teacher at the school. 04 [REDACTED] provided the attached written statement. In summary the statement reads as follows:

Around 9:35 myself and another reading teacher were working with 4 students in room 0 when we heard heavy/strange breathing over the loudspeaker. It went on for a bit so the other teacher said, "Should I call the office and let them know the phone is off the hook?" I said, "Yes", so the other teacher, 04, called the office and I heard her say, "Hello...who's this?" She closed the door as she hung up the phone and said "we need to get down." We grabbed our kids and got them under a table. I got my keys and opened the door to lock it. I told 04 to move our 4 kids to the other side of the room out of the doors view and then I taped paper to block the "O" window on our door. Then I went and closed the blindest at the back of the room and saw someone (possibly a police officer-khaki pants and black pea coat running toward the portables). Then I heard "GET BACK! STAY DOWN" I tried to lock the adjoining door to the classroom but I couldn't so I moved an easel and a table in front of it. Then I went back to the floor near the computers with the kids and 04. We tried calling 911 but couldn't get service so I notified my husband to call Newtown Police. When he called me back I heard what sounded like police "walkie-talkies" in the hallway. We heard people on the loudspeaker but it was a bit muffled and my kids were whispering so I don't really know what they said. Some time went by and we heard doors attempting to be opened. Then the police were talking in the hallway and unlocked our door. We were told to come out with our eyes closed, and we escorted them out the door, part the playground, and down to the firehouse.

Room 04 is located at the back of the school and on the back side. Had the intercom not been on, I don't feel that we would have heard or realized there was trouble until it was too late. END OF STATEMENT
