INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

I quickly shut the door and we (there was [REDACTED] 04 [REDACTED] in the classroom.) had the children go into the closet area and remain seated on the floor asking them to be silent. We did hear more gunshots (not quite sure how long they went on.) I called 911. After some time a police man did come to the door and we were instructed to walk out of the building in a line and we came to the fire department.
