INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

On Friday, December 14th, 2012 between 1340 and 1350 hours I, Det. Roy # 518, interviewed [REDACTED] 04 was a teacher within the school at the time of the shooting [REDACTED] 04 provided the attached written statement. In summary, the statement reads as follows:

I was in my classroom this morning with 19 children (all present), my assistant [REDACTED] 04. Children were on the carpet and noises were heard on the PA system. (Sounded like gunshot). We immediately took the children to the cubby area and did a lock-down drill (blinds closed, windows covered, door locked, and lights off.) We read children stories, talked with them to remain calm. Lots of shots were heard. After about 30 minutes, we heard banging at the door. Police told us to take the kids of the building to a safe place, cover our eyes, hold hands, and we lead them to the firehouse for safety. Parents came and picked up kids to bring home. I'm familiar with gunshots because I have family in law enforcement. There were lots of shots, pauses, then more shots. We exited the building by coming down the hall to room 2 and left the building.
