INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

On Friday, December 14th, 2012 between approximately 1340 and 1410 hours I, Det. Roy # 518, interviewed [REDACTED] 04 was a teacher within the school at the time of the shooting. [REDACTED] 04 provided the attached written statement. In summary, the statement reads as

follows:

I arrived at the school at 8:25 a.m. I'm a teacher at Sandy Hook. I teach [REDACTED] 04 homeroom from 8:25 – 9:25. At 9:25 I brought them to the [REDACTED] 04) I began to show them a Nutcracker DVD. Soon after it started I heard noise in the hall and thought it was the custodian moving things. I looked out my door and [REDACTED] 04 across the hall said to lock the door. I locked my door and decided I heard shots. I put my whole class at this point into the closet in the back of the room. I kept the students quite and calm. We held hands and prayed. I called 911 twice while we were in there and gave them information as to where we were. The second door to the closet rattled at one point. I heard the police at my classroom door. I exited the closet leaving the students locked up and verified it was the police. I let the kids out and we ran out with the police. At some point I heard a lot of commotion in the hall. Someone opened the bathroom. The intercom was on and I could hear shots and commotion. I thought I heard someone shout "Get out of our school, or I'm gonna get this school." At first I told the kids it was a drill or an animal. Then I had to tell them there was a bad guy in our school.

Shots heard: There were a lot of shots then a pause then many more shots, then another pause plus more shots. END OF STATEMENT
