INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

On Friday, December 14th, 2012 between 1152 and 1239 hours I, Det. Roy # 518, interviewed **04** was a teacher within the school at the time of the shooting. **04** provided the attached written statement. In summary, the statement reads as follows:

I'm making this statement in regards to a shooting at the school I work at. I've been employed at the Sandy Hook Elementary School of the past 04 years as a 04. I work in 04 with 04 and at around 9:30 we had one student 01 02 03 12, in the class with 04 and I. We heard loud bangs that became successive, 50-100, and it was becoming louder as it was moving towards our room. We heard a lot of kids screaming next door so we hid in a small bathroom. We have a wooden apple that hangs on our door into our class. I heard the apple hit the door, I know he was in our room and I heard a couple of bangs, but I don't know if it was in our room. I didn't hear the door close again. I say male because when it was next door in 04 room I could hear a male voice and all the noise. Bangs started by the front office and progressively got louder as it came to our room. We were unsure if anyone was still in the room so we cracked the door. I could smell the gun smoke. The best way I could describe it is it smelled like something burning. I had heard some more banging but not sure if in the hall or where it was coming from. When we cracked the door we could see police lights and multiple police officers in the front. I could hear the officer next door say "You guys did a great job.", so I knew it was the police. I also heard someone say that a room was swept and that's when we came out yelling. An officer was standing outside the door told us to go out the front. I never saw the shooter nor did I know of any threats against the school or any teachers. A substitute named Lauren Russeau and a special services teacher Rachael DeVino were in room #8 with kids.
