JUVENILE INTERVIEW OF [REDACTED] 01 02 03 12

ACTION TAKEN: On Friday December 14, 2012 at approximately 1250 hours, Detective Jeremy Combes and I met with [REDACTED] 01 02 03 12 and his parents [REDACTED] 01 02 03 12, 04 at the Newtown Police Department located at 3 Main Street in the town of Newtown. [REDACTED] 01 02 03 12, 04 had brought their son to the police department so he could share what he had seen and heard while in Sandy Hook School earlier that morning. Det. Combes and I brought the [REDACTED] 01 02 03 12, 04 to a lieutenant's office within the PD for the purpose of this interview.

In a verbal and later in a written statement given in the presence of his parents, [REDACTED] 01 02 03 12, 04 stated that he went to school today at the Sandy Hook School where he is in [REDACTED] 01 02 03 12 class. He states he was doing his morning work getting ready to do writing when a man walked in. He was wearing a brown or camo shirt, brown pants, a hat that was like a sombrero but smaller that was also brown. He goes on to state that the man had a bazooka that was black, brown or camo. He was also wearing sunglasses. [REDACTED] 01 02 03 12 goes on to state that the man didn't say anything. He stated he heard a banging sound that was like a hammer. [REDACTED] 01 02 03 12 stated that he does not know who the man pointed the bazooka at. He continues stating that they ran out of the class. He reports running with [REDACTED] 01 02 03 12. He stated that they ran and got into a car driven by a woman that [REDACTED] 01 02 03 12 knew. In addition, [REDACTED] 01 02 03 12 said that he saw bullets on the ground. He said they were yellow and the tips were red. [REDACTED] 01 02 03 12 written statement is attached to this report.

At approximately 1330 hours the statement was concluded with [REDACTED] 01 02 03 12 and his parents all signing the document. [REDACTED] 01 02 03 12 and his parents left the police station shortly after that.
