04 and was working at the time of the incident.

ACTION
TAKEN:

On 12/14/12 at approximately 1354 hours, I interviewed 04 within an office at the Fire Department. 04 stated verbally and later in a sworn written statement that she is the Sandy Hook Elementary 04 and has been working there for the past 04 years.

On December 14th, 2012, 04 arrived for her scheduled day from 8:45am to 3:45pm. She was working within her office which is located near the main entrance of the school. 04, was also present and working within her office, which is a separate office than 04 stated from her office she does not have a clear view to the main entrance. She further stated that it was a normal day and nothing seemed out of the ordinary.

At approximately 9:30am she was on the phone with her daughter when she heard a loud "popping" noise. As she got off the phone with her daughter, 04 had called out, "04 With the "popping" noises and 04 demeanor and tone, she knew something was wrong. 04 hid underneath the computer desk. Through a hole in the back of the computer desk, she observed from the knees down a person standing directly in front of her, with feet pointed towards her. This person was approximately 20 feet from where she was hiding. The person didn't speak, leading her to believe that the person was the only one in the room. The person's pants looked dark blue and the boots were black. This person stood there for approximately five seconds. The person's feet then started to walk towards the hallway. A few seconds later, she heard "a lot more popping" which seemed to be in bursts of five or six. As the "popping" continued it seemed to get more distant from her, indicating the person was walking down the hallway. 04 then ran around to the back of 04 computer desk, grabbing the telephone and bringing it to the ground. 04 called 911, requesting help for a shooter in the school. After the 911 call, 04 started to hear screaming. 04 then hid in a closet. 04 recalls the "popping" seemed to last forever. When the "popping" stopped, she didn't hear any voices, which lead her to believe the school followed protocol and was on lockdown. As time went by, 04 heard muffled voices, but 04 were afraid that there could be more shooters. After some time, 04 opened the door and noticed the time of 11am. She peeked out a little more and observed several men with guns, appearing as SWAT
