Interview:

On 12/14/12, at approximately 1225 hours, this Detective met with 04, 03 at the Sandy Hook firehouse, with regards to the ongoing investigation.

During the interview, 04 stated, in part, the following:

That on 12/14/12, she was in her 04 classroom at Sandy Hook Elementary School, 04, when she heard a succession of loud popping noises that sounded to her like the sound of metal trays dropping on the floor. 04 stated that the noises went on for a few seconds, and at approximately 9:30 or 9:35 a.m., she brought her students into the cubby area and locked her classroom door. 04 stated that she could hear muffled crying over the loudspeaker, and relayed that she observed police officers with guns outside of her classroom by the playground area. 04 stated that a team of approximately 5 police officers knocked on her classroom door and escorted her and her students out into the hallway. 04 stated that they all held hands and walked to the Sandy Hook firehouse.
