was not. 04 stated that she continued to hear popping noises and children screaming and that they remained in the closet until the State Police attempted to gain access, at which time they came out.

stated that she does not enter the school building each day through the front doors, but rather she and 04 to enter 04 of the stated that she has to punch in at work every day, and did so at 6:57 a.m. 04 stated that when she arrived at work on the morning of the 14th, there were only two other cars in the parking lot, and that she saw the principal pull in and park behind her car.
