Incident Summary:

On 12/14/2012 at 0941 hrs. State Police personnel were assigned to respond to the Sandy Hook Elementary School for a reported active shooter situation. Upon arrival State Police personnel discovered multiple persons deceased, including twenty (20) children, six (6) school personnel, and what was later determined to be the sole assailant. Detectives from the Central District Major Crime Squad were subsequently assigned to assist the

Action Taken:

On 12/14/2012 this investigator and Trooper Brian Connolly #431 (Central District Major Crime Detective) responded to Bridgeport Hospital, located at 267 Grand Street, Bridgeport, CT 06610, to interview a victim from this incident. This victim had been identified as [REDACTED] 04, 03 [REDACTED] at Sandy Hook Elementary School, Newtown. [REDACTED] 04 [REDACTED] had been injured in this incident, with her injuries consisting of a severe laceration to the arch on the left foot. Upon her extraction from the school, she had been transported to Bridgeport Hospital for medical treatment. [REDACTED] 04 [REDACTED] gave the following sworn statement:

Statement of [REDACTED] 04, 03 [REDACTED]

My name is [REDACTED] 04 [REDACTED] and I am giving this statement to Trooper McDonald and Trooper Connolly about the shooting that happened at Sandy Hook Elementary School today (12/14/12). I arrived at school for work at about 8:00 AM. I am a [REDACTED] 04 [REDACTED] at Sandy Hook and I teach the [REDACTED] 04 [REDACTED]. I know that the doors are usually locked at around 9:30 AM, and nothing unusual happened during the first part of the morning. The kids start coming into the classroom at around 9:07 AM. At around 9:30 AM I was in my classroom with [REDACTED] 04 [REDACTED] who are aides that help out. I was also in there with [REDACTED] 04 [REDACTED]. At around this time I heard some weird noises out in the hallway. I went to the hallway door in my classroom and went out into the hall to see what was going on. The noises sounded like metal banging, or like someone had dropped something. I don't really remember hearing anything else, or seeing anyone in the hallway. I remember that as I walked out into the hallway I felt the hallway vibrate beneath my foot. I didn't think too much of it and walked into the classroom, and shut and locked the door behind me. I then went to shut and lock the door in the back of the classroom, and it was at this point that I noticed that my foot was bleeding. As I was closing the front door to my classroom I heard a second round of the noises. At this point I knew that something was wrong. I then made sure that my classroom was locked down and got my kids and the two other adults in to the safe area. I called 911 at this point to let them know what was going on. About 1/2 hour later the police got to my classroom to evacuate us. I saw the police earlier, but it took about 1/2 hour to get out of the classroom. My classroom is room [REDACTED] 04 My room is at [REDACTED] 04 [REDACTED]. The other classroom is [REDACTED] 04 I heard several sounds which I now know are gunshots. I really don't know how many. If anything comes to mind, or if I remember anything important I will contact Trooper McDonald or Trooper Connolly. My left foot was injured, and my shoe was removed. I think it was taken off at the entrance to the parking lot. It is a black Sketchers, size women's 10, and from my left foot. My foot was the only part of me injured. I don't know of any teachers or staff that were having personal problems, or anyone who would want to do something like this. ###END### (See written statement)

Action Taken Continued:

04 consented in writing to having her injuries examined and photographed, and to the examination of her personal property. This property had been secured by Bridgeport Hospital Nurse Anita Shrum (DOB 03), and subsequently seized as evidence by Trooper Guiliano #958, who had been posted at the hospital by Troop G - Bridgeport. These items were initially secured by Nurse Shrum upon 04 arrival to the hospital, and transferred to Trooper Guiliano at approximately 1300 hours on 12/14/2012. Trooper Guiliano transferred custody of these items to this investigator at approximately 1540 hours on 12/14/2012. These items were subsequently transported to Troop A - Southbury by this investigator, seized into evidence, and are detailed in a separate evidence report along with the relevant DPS-167-C - Consent to Search and Examine Evidence.

All photographs taken that relate to 04 are detailed in a separate report completed by Trooper Connolly.

Case Status:

This case remains active and under investigation by the Western District Major Crime Squad.
