Interview: On 12/14/12, at approximately 1210 hours, this Detective interviewed 04, 03 at the Sandy Hook firehouse regarding the ongoing investigation. During the interview, 04 stated, in part, the following:

That at approximately 9:40 a.m. she was in the 04 when she heard a series of loud bangs. 04 explained that she thought the noise was from the custodian putting the risers up or down for chorus practice.

04 stated that a short time later, she heard the bangs again, at which time 04 coworker, 04, looked into the hallway and shouted to any students that they needed to get into their classrooms. 04 stated that 04 got the key to the classroom and locked the door. 04 stated that she, 04 and a third coworker, named 04, hid in the closet in the 04.

04 stated that she could hear the custodian, Rick, running down the hallway talking on the telephone and stating that it was "still happening." 04 stated that shortly afterward, she heard two different series of shots and heard the police yelling "hands up!" nearby.

04 stated that she recollected that the school was otherwise quiet, except for the sound of boots running down the hallway, which she heard happen on two separate occasions.

04 stated that for much of the time during the incident the intercom/loudspeaker from the main office was on, and she could hear the voice of a distraught female being transmitted, but could not recall what, if anything, the voice was saying.

04 stated that at least twice during the quiet times she could hear a vibrating or humming sound, but did not identify or clarify where the noise appeared to be coming from.

04 stated that eventually, she and her coworkers heard the police giving orders to get "out," and telling students to walk out and close their eyes, at which time they peeked out of the 04 and visually verified that the orders were coming from uniformed officers before exiting the building with the students.

See attached written statement prepared by and sworn to by 04 and witnessed and notarized by this Detective.

The status of the case remains actively under investigation.
