ot stated that she recollected that the school was otherwise quiet, except for the sound of boots running down the hallway, which she heard happen on two separate occasions.

04 stated that for much of the time during the incident the intercom/loudspeaker from the main office was on, and she could hear the voice of a distraught female being transmitted, but could not recall what, if anything, the voice was saying.

04 stated that at least twice during the quiet times she could hear a vibrating or humming sound, but did not identify or clarify where the noise appeared to be coming from.

ot stated that eventually, she and her coworkers heard the police giving orders to get "out," and telling students to walk out and close their eyes, at which time they peeked out of the **04** and visually verified that the orders were coming from uniformed officers before exiting the building with the students.

See attached written statement prepared by and sworn to by 04 and witnessed and notarized by this Detective.

The status of the case remains actively under investigation.
