Interview: On 12/14/12, at approximately 1220 hours, this Detective met with 03, 04, with regards to the ongoing investigation. During the interview, 04 stated, in part, the following:

That she had arrived at Sandy Hook Elementary School at approximately 0845 hours on 12/14/12, and had not observed anything suspicious or unusual that morning, or in the past few days or weeks.

04 stated that at approximately 9:45 a.m., she heard a popping sound and what she believed sounded like laughing come across the library intercom. 04 stated that her colleague called the office and then told 04 that it was a "lockdown." 04 stated that she did not know whom her colleague had spoken to or what she was told over the phone. 04 stated that they followed the protocol for a lockdown and covered the windows, pulled the shades down and put all the students in a certain area as they had been taught.

04 stated that at 9:51 a.m., she called 911 from her cell phone. 04 stated that when her supervisor saw the police out in the hallway, she had her students crawl to the library kitchen closet and they barricaded themselves in, locking the door and putting filing cabinets against the locked
