Interview: On 12/14/12, at approximately 1130 hours, this Detective was approached at the Sandy Hook firehouse by 01 02 03 12, 04 01 02 03 12 student at Sandy Hook Elementary School, regarding the ongoing investigation.

01 02 03 12, 04 advised that she did not know what the best course of action for the circumstances was, but that her son had witnessed his teacher being shot and wanted to talk to an officer and relay what he had seen. This Detective observed that 01 02 03 12 were with 01 02 03 12, 04, and were listening to the conversation. This Detective asked the 01 02 03 12, 04 family to follow her outside and then asked 01 02 03 12 if he wanted to talk about what he had seen. 01 02 03 12 stated that he did and relayed, in part, the following:

That he is a 01 02 03 12 class at Sandy Hook Elementary School, and was in his classroom at the time of the incident. 01 02 03 12 stated that he and his classmates had just started writing when they heard something loud out in the hallway. 01 02 03 12 stated that he thought that the loud noise was shouting. 01 02 03 12 stated that a guy kicked open the door and shot his teacher, 01 02 03 12. 01 02 03 12 stated that the male shooter didn't say anything to anyone, and described the shooter as a white guy with a heavy winter-like brown jacket, and a green shirt underneath the jacket. 01 02 03 12 stated that he believed the man was wearing army green kind of pants, and described him as having dark hair, longer on the top

than on the bottom, with no beard or moustache. [01 02 03 12] was asked if the man was young or old and struggled with the answer, until he was aided by his mother, who asked if the male was younger or older than an acquaintance of their family's, at which time [01 02 03 12] stated that the shooter was about the same age. [01 02 03 12, 04] clarified that the male that she had used as a reference was in his 20's.

[01 02 03 12] stated that he and all the other kids ran out of the classroom and kept running out of the school building until they got picked up by a bus driver who drove them all to a house.
