stated that they listened to the shooting for a while and then a door opened and a police officer stuck his head into the room using a door that wasn't locked after all. 04 stated that they moved the students into a closet behind two locked doors and moved 2 filing cabinets in front to block them before settling the students down to color. 04 stated that they remained there until they believed they were safe even after the police pounded on the door for them to come out.

On 12/14/12, 04 drew a rudimentary sketch of the path of travel she believed the gunman had taken and labeled where 04 was in relation to the shooter (see attached).

See attached written statement prepared by, sworn to and signed by 04 and witnessed and notarized by this Detective.

The status of the case remains actively under investigation.
