Interview: On 12/14/12, this Detective met with Sandy Hook Elementary School 04, 03, with regards to the ongoing investigation. The interview was conducted at the Sandy Hook firehouse, and during the interview, 04 stated, in part, the following:

That 04 in the S.H.E.S. 04 stated that on the morning of 12/14/12, she was working with three adults identified as being 04, who was, at the time teaching 04 grade class.

04 stated that she heard the P.A. system for the school turn on, and she heard crying noises transmitting over it. 04 stated that she called the main office to tell them, believing that someone had turned it on by accident. 04 stated that 04 answered the telephone and said "there's shooting."

04 stated that she hung up and yelled "Lockdown!" and slammed the door shut. 04 stated that she returned to the library and the adults ushered the students to the lockdown spot while 04 locked the doors. 04 stated that by this time they could hear a lot of shots being fired rapidly, and 04 called 911 and was told that the police already knew.

04 stated that they listened to the shooting for a while and then a door opened and a police officer stuck his head into the room using a door that wasn't locked after all. 04 stated that they moved the students into a closet behind two locked doors and moved 2 filing cabinets in front to block them before settling the students down to color. 04 stated that they remained there until they believed they were safe even after the police pounded on the door for them to come out.

On 12/14/12, 04 drew a rudimentary sketch of the path of travel she believed the gunman had taken and labeled where 04 was in relation to the shooter (see attached).

See attached written statement prepared by, sworn to and signed by 04 and witnessed and notarized by this Detective.

The status of the case remains actively under investigation.
