04 was interviewed in conjunction with the Sandy Hook Elementary School mass shooting investigation. 04 was present in the building located at #12 Dickinson Drive in the Town of Newtown during the shooting and although she did not witness the individual responsible

for the killing of the victims, [04] heard the gunshots and interacted with other staff members during the murderous incident.

[04] was interviewed in the main parking area located within the Sandy Hook Fire Department located at #18-20 Riverside Road in the Town of Newtown, CT. While being interviewed, [04] hand wrote and documented her knowledge of the event on a DPS-683-C CSP Witness Statement form. While speaking with [04] she remained calm, articulate and responsive to all questions asked of her.

ACTION TAKEN: On Friday, December 14, 2012 [04] was interviewed and stated both verbally and/or in a written statement that she is a [04] teacher at the Sandy Hook Elementary School located in Newtown, CT. [04] stated she was waiting in Room [04] located in the back hallway of the school for her first group of students to arrive at 9:30 am. [04] stated when only one student arrived, she sent the student to pick up the other members of the group. [04] stated at approximately 9:35 am she began to hear a "metallic pop" sound which she thought, at the time, was coming from the roof. [04] stated she hurried her students into the classroom and telephoned the main office where she spoke with [04] who stated "someone is in the building shooting." [04] stated her co-worker [04] locked the door; they covered the window with paper and hid the children behind the book shelf and under the computer table. [04] stated while in hiding, they played a game with the children to keep them calm, as they continued to hear gunshots for "over a period of 5-10 min." [04] stated throughout this tragic event, she could hear people talking over the intercom which apparently was left open and at one point Police Officers were telling someone, "you're o.k. now." [04] concluded by stating they remained in room [04] until the police came to get them.
