DEEP officer, Hilli provided a typed statement.

"On 12/14/2012, I Environmental Conservation (ENCON) Police Officer Hilli #676 and ENCON Ofc. Keith Williams #638 were at Derby Court applying for a search warrant regarding a fatal boating accident that had occurred on 12/7/2012. Upon completion of approval of the search warrant (reviewed and signed by Judge) we returned to our patrol vehicles (drove separately). I contacted Sgt Dwyer (via phone) to advise him of the warrant status, Sgt Dwyer advised that there was an active school shooting in Newtown. Ofc. Williams and I responded with lights and siren to the Sandy Hook Elementary School. We were the first ENCON Ofc. that responded. When we got to the school, an ambulance was turning around leaving the scene. Ofc. Williams and I both deployed our AR-15, I also grabbed my trauma kit. There was a State Police Sgt. near the front of the building, I asked him where he wanted me, he saw my trauma bag and told me to check kids. I next assisted groups of students and teachers that were exiting the building (from the Southeast corner) of the school. Ofc. Williams was sending the groups from his location towards me, I was checking, guiding and directing students and teachers towards the Fire House. During the course of events, I talked with CSP Detective Luckienchuk, the Detective had responded in civilian clothes and identified himself (I was previously familiar with this officer). We, Det. Luckienchuk and I continued to facilitate evacuating groups of children and teachers. Once the children had been evacuated I took a post Southeast side of the building. Additional children and teachers exited this side of the building sporadically until there were no more evacuating. I would assist with evacuating and then return to my Southeast post. Once there were no more evacuees. I took a post along side of Ofc. Williams (Southeast side of building). We secured this area, CSP Ofc. Bukowski #763 became concerned with some perimeter movement on Creastwood Road. Ofc. Williams went with Ofc. Bukowski. They made numerous contacts with persons and vehicles on this road (felony stops). During this time frame additional ENCON Officers responded, Sgt. K. Schneider #627, Ofc. Bernier #628 (they secured Southeast perimeter near my location). Capt. Camejo #689 was the next respondent to my area. The last ENCON responding Ofc. to my location was Ofc. Buckly #624. There were additional ENCON Ofc. covering the perimeter of the other side of the school. We all (ENCON Officers) maintained the perimeter security for several hours. We were relieved of perimeter security by Newtown Officers."

The typed statement was signed by officer Hilli, witnessed by Detective Lukienchuk #573 and I notarized the statement.
