"On 12/14/12 at approx. 0940 hours, I was working a private duty side job for Yankee Gas in the area of 44 Botsford Hill Road. I heard Newtown Police dispatcher, Bob Nute advised patrols that there was a report of gun shots coming from Sandy Hook School. Nute then transmitted that the front window had been shot out and that there was someone injured in the leg. I left my job and responded to the scene. Nute continued to transmit that gunfire is still being reported being heard. Ofc. McGowan reported he was out and I heard him say he was out with a male behind the school by Crestwood. Other officers called out at the scene. I heard radio transmissions requesting ambulances and that they have bodies. I heard Ofc Smith say "We have a suspect down" I don't know when I arrived at scene, approx. 3-5 minutes after the initial call. I pulled into the entrance of the school parking lot, and saw several parents walking. I told them to get back into their vehicles. I then parked my cruiser (#16) in the western section of the parking lot. I started to head toward the front door and observed Ofc. Chapman, with a rifle. I called out to Chapman and asked him what he needs me to do and Chapman told me that there are two parents behind the dumpsters. I then went over to the dumpsters and took a position, protecting the parents and watching the northeast corner of the building. There was a black Honda Civic, parked in a fire lane, parked to the right of the main entrance. The front passenger door was open and there were two sweatshirts on the ground on the passenger side. Sometime later, I saw Lt. Vanghele carry a small child out of the school in his arms and headed towards the ambulance. I then saw a female that was being pushed on a chair and put in the back of the Lieutenant's vehicle and then headed off towards the ambulance. Ofc. Penna came over and secured the car and he pulled a long gun out of the second row seat of the Honda Civic and secured it into the trunk of the car. Ofc. Penna then secured the closed the open door. Ofc. Penna then took a post at the northwest corner of school and I then escorted the two parents to the safe zone. I went back to my post until two CT DEEP officers relieved me. I then was assigned to put crime scene tape blocking off the entrance to the school and around the Honda Civic. I then went back to my post and stayed there till I was assigned to take a post at the intersection of Bressan Farm Road and Yoganada Street to prevent people from going to 36 Yoganada Street. I remained on the scene, with Ofc. McClusky till 12/15/12 at 0100."

The typed statement was signed by officer Hull, witnessed by Detective Lukienchuk #573 and I notarized the statement.
