Incident Summary:

On 12/14/2012 at 0941 hrs. State Police personnel were assigned to respond to the Sandy Hook Elementary School for a reported active shooter situation. Upon arrival State Police personnel discovered multiple persons deceased, including twenty (20) children, six (6) school personnel, and what was later determined to be the sole assailant. Detectives from the Central District Major Crime Squad were subsequently assigned to assist the

Action Taken:

On 12/15/2012 this investigator and Trooper Brian Connolly #431 (Central District Major Crime Detective) were assigned to interview several emergency medical technicians from the Newtown Ambulance Service that had responded to this incident. These personnel were located at the Sandy Hook Firehouse located at the intersection of Riverside Road and Dickinson Drive, Newtown, CT.

The following sworn statement was given by Chelsea Fowler (DOB [REDACTED] 03 [REDACTED]), an EMT-B that had responded to Sandy Hook Elementary School on 12/14/2012:

Statement of Chelsea Fowler (DOB [REDACTED] 03 [REDACTED]):

My name is Chelsea Fowler and I have been in EMS for about six years. I volunteer for Newtown Ambulance, and am currently certified as an EMT-B. On 12/14/12 at about 9:45 I heard the initial dispatch for an ambulance standby at Sandy Hook Elementary. A few minutes later I heard a second tone out and decided to respond. I got up to the scene at about 10:00. When I got up to the scene I was stopped by the State Police and was told the scene wasn't safe. I then proceeded up to primary triage, located at the front of the school. The only person who was wounded was a teacher who was shot in the foot. I was walking her down to the treatment area when a group of students came running out of the school. One of the students yelled out to her to ask if she was ok, and she responded "I'm just fine, I only sprained my ankle!" I think she is very brave. Once I got her to the treatment area at the firehouse I turned over her care to other personnel, and went back up to triage. We waited for more wounded, but found out later that there were none. I stayed at the school to help out, and left around 2:45. I then left to go to the firehouse and helped out with what I could, and helped out the families in any way I could. ###END### (See written statement)

Action Taken Continued:

The two other EMT personnel present were identified as Jill Uricioli (DOB [REDACTED] 03 [REDACTED]) and Laurie Veillette (DOB [REDACTED] 03 [REDACTED]). These two individuals were also interviewed, with their statements being detailed in a separate supplementary report by Trooper Connolly.
