Action Taken: On 12/14/12 at approximately 1000 hours, this Trooper was dispatched by Troop A to 12 Dickinson Drive in Sandy Hook, the Sandy Hook Elementary School for an active shooter. This Trooper and assigned State Police patrol canine, K9 Luger, # 9054 arrived on scene at approximately 1030 hours. This Trooper was assigned by Lt. Davis and Lt. Hofbauer to take a perimeter with K9 Luger at the exterior of the elementary school. This Trooper and K9 Luger posted at the northeast corner of the building with a Newtown patrol officer. Three additional K9 units later arrived on scene and eventually every corner of the exterior building was covered with a canine while ESU search teams cleared the interior of the building.

When the building was cleared by the State Police tactical team, this Trooper was assigned by Lt. Hofbauer to conduct an area search of the wooded area that surround the entire school. This Trooper, along with Tpr. Katrenya, # 555 and Newtown Police officer Chapman searched the area west of the school with negative results. TFC Bennechi # 1413 searched the eastern area with his assigned canine with negative results.

Canine Qualifications: K9 Luger is a 6 year old male German Shepherd. Luger is a certified patrol canine. Luger was certified by the Connecticut State Police canine unit in May of 2008.
