

ACTION TAKEN: On 12/14/2012 at approximately 0700 hours, I was assigned to work an HCP overtime job in the area of Route 25 in the Town of Trumbull (project number:dot01440179n). At approximately 0935hours, I was driving in the area of Route 25 in the Town of Monroe when I was informed that there was an active shooter incident occurring at the Sandy Hook Elementary School located at 12 Dickinson Drive in the Town of Newtown. I determined that I was approximately 6 miles from that location and informed one of the project employees that I was leaving the sight. I initiated the lights and siren on my assigned cruiser (CT 189WWL), informed Troop A that I was en route, and headed to the Sandy Hook Elementary School. While en route, I heard many transmissions on Troop A radio and specifically remember hearing, "Set up a perimeter", "Classroom 9", "the Kindergarten room" and "possible second shooter".

Upon arrival, as I turned right onto Dickinson Drive, I observed a firehouse (later identified as the Sandy Hook Firehouse) to my left and several fire personnel directing traffic. As I continued up Dickinson Drive, I was able to see what I believed to be Sandy Hook Elementary School at the end of the road. I drove my assigned cruiser as close to the school as I could, at which time, I observed children and adults running in different directions. It was my impression that these children had run from the school and the adults were parents. I recall thinking that it was a very chaotic scene. As I placed my assigned cruiser in park, I heard a transmission on the Troop A radio that led me to believe that the shooter was down and was no longer a threat. I can not specifically recall that exact transmission.

As I exited my assigned cruiser, an adult male and female ran towards me and informed me that their child was a student at the Sandy Hook Elementary School and they could not locate him. Several other adults followed them and advised me of the same. I do not recall what my response to them was, as I ran towards the school. As I approached the school, it was apparent to me that a perimeter was set up with police officers from various departments. At that time, I observed several frantic adults in the school parking lot, who I assumed where parents of children inside the school, attempting to get close to the school. I assisted with keeping the adults away from the school. At that time, I observed three vehicles

parked in the first row in the front of the school, with what I believed to be bullet holes in them. I also observed shattered glass at the entrance to the school and shattered glass in one of the classroom windows facing the parking lot. I also observed a black four door sedan parked next to the entrance of the school. I recall that the vehicle appeared to be out of place and not in a designated parking space.

I then observed children being escorted out of the school. I observed that some children were running and other children were walking quickly in a single file line. At that time, I began assisting with escorting the children from the school to the Sandy Hook Firehouse. I recall that several children were crying, shaking, and appeared very scared. I recall that some children were met by adults who I assumed were their parents before we made it to the firehouse. I can not recall the exact time, but at some point I remained at the Sandy Hook Firehouse. At the firehouse, I was assigned the following: assisting in reunifying children with their parents, assisting with statement taking of witnesses, assisting Dr. Janet Robinson, Superintendent of the Newtown School System with coordinating with the State Police, and remaining with families who could not locate their children or relatives.
